William S. ... of the 126th Regiment of Ohio Vol. Inf. at Camp ... on the 20 day of August, 1862 to serve 5 years; he was born in Lucas Co. in the State of Ohio, is 36 years of age, 5 feet 10 inches high, fair complexion, blue eyes, dark hair, and by occupation when enlisted a ... During the last two months said soldier has been unfit for duty 60 days. Said soldier was wounded July 9, 1863 at the battle of Monroeville while in line of duty as a soldier.
